1. Introduction

All schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- Increase the extent to which disabled learners can participate in the curriculum.
- Improve the physical environment of the school to enable disabled learners to take better advantage of education, benefits, facilities and services provided.
- Improve the availability of accessible information to disabled learners.

Greenside School is a community, day special school for 165 learners aged 2-19 years who have severe or profound and multiple learning difficulties (SLD / PMLD). In partnership with North Hertfordshire College (NHC), Greenside offers provision for up to 5 post 19 students who have a profound learning difficulty. All learners have an Education Health Care Plan (EHCP).

Greenside is co-located with Barnwell Middle School. A shared use agreement is in place. Greenside leases 3 premises in the local shopping centre (The Hyde), which are used to promote the development of vocational, social interaction and independence skills.

Greenside works in partnership with local primary schools to provide initial teacher training opportunities.

2. Values, Legislation and Guidance

Greenside School provides access and opportunities for all learners without discrimination of any kind.

The values of Greenside School are: **Respect, Creativity** and **Collaboration** is reflected in the school's motto **Learning – Achieving – Together**

Our school is also committed to ensuring staff are trained in equality issues with reference to the Equality Act 2010, including understanding disability issues.

The school supports any available partnerships to develop and implement the plan. Greenside is co-located with Barnwell Middle School. Service level agreements enable the sharing of facilities at this secondary school.

At Greenside, our complaints procedure sets out the process for raising these concerns about accessibility.

This document meets the requirements of <u>schedule 10 of the Equality Act 2010</u> and the Department for Education (DfE) <u>guidance for schools on the Equality Act 2010</u>.

The Equality Act 2010 defines an individual as disabled if he or she has a physical or mental impairment that has a 'substantial' and 'long-term' adverse effect on his or her ability to undertake normal day to day activities.

Under the <u>Special Educational Needs and Disability (SEND) Code of Practice</u>, 'long-term' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial'. The definition includes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make 'reasonable adjustments' for learners with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a disabled pupil faces in comparison with non-disabled learners, this can include, for example, the provision of an auxiliary aid or adjustments to premises.

3. Curriculum Access

Greenside offers a broad, relevant and highly personalised curriculum that is tailored to the learning, emotional, sensory and physical needs of each learner. The learning outcomes from each Education Health Care Plan (EHCP) inform planning, practice and assessment. Access to the curriculum is supported through the appropriate use of:

- Augmented Assisted Communication (AAC) specialist
- Sensory literacy
- Communication passports
- Behaviour support team who promote therapeutic practice and oversee risk reduction plans, sensory diets and anxiety mapping
- Assisted eating plans
- Specialist approaches to support ASC learners including: SCERTS, TEACCH, AET, Attention Autism,
- Speech therapy
- Physiotherapy.
- Nursing care
- Moving and handling plans
- Sensory integration.
- Intensive Interaction.
- Drama therapy
- Rebound therapy
- Specialist in dance, drama, massage and music
- Mental health first aid practitioners.

Specialist facilities, resources include:

- Warm water swimming pool;
- Garden areas including a sensory garden
- Soft play room,
- Sensory integration room,
- Accessible swing, roundabout and sand pit.
- Range of accessible trikes.
- Single switch(s) iPads; touch screens, adapted keyboards, Eye gaze technology,
- Multi-sensory rooms and areas
- Low arousal room
- Riding for the Disabled.
- Specialist seating, standing + moving and handling equipment
- Adapted Food Technology Rooms
- 4 mini buses (of which 3 accessible for wheelchair users)
- 2 cars (1 is accessible for wheelchair users)

Inclusive learning opportunities include:

- Partnership with local primary schools
- Colocation with Barnwell Middle School 2 Post 16 classes are based at Barnwell. KS 3 / 4 learners eat their lunch with peers in the Barnwell Bistro; the librarian is employed by both schools; use of sports center. Science laborites; dance studio; music rooms. Joint dance lessons. Joint reading lessons;
- Partnership with North Hertfordshire college (NHC)
- Riding for the Disabled (RDA)

Vocational learning opportunities include:

- Social enterprise (Greenside Studio);
- Post 19 provision for students
- Church Farm; work experience.
